## FEES AND POLICIES FOR THE SUMMER PROGRAM

(For more information on ASC policies refer to your parent handbook)

# **Registration and Tuition:**

- Non-refundable registration fee: \$35 for one child and \$50 per family.
- Non field trip days are \$65 and Field trip days are \$80.
- At the time of registration, the registration fee plus the non-refundable deposit of \$10 per day must be paid.

## Payment:

- Weekly tuition payments are due on <u>Wednesday by 5:00 pm</u> for the following week.
- Any spot not paid for by then will be offered to a child on the waiting list and a late fee of \$15 will be added to the bill.
- The entire week's tuition will be forfeited if this is the case. No child may attend unless the entire weekly bill has been paid in advance.

  All weekly tuition must be paid by August 4th.

#### Sunscreen:

- Non-refundable sunscreen fee is \$25. We will be using Rocky Mountain SPF Kids 50 sunscreen.

## **Check returns:**

- \$10 fee will be added to the child's bill.
- The funds to cover the returned check plus the \$10 are due within five days.

## Late pick up:

- After 5:00 p.m., you will be charged \$1 per minute.
- On the 5<sup>th</sup> time, the charge will go to \$5 per minute until the end of the summer.

## **Enrollment changes:**

- TWO WEEKS' notice is required to be refunded excluding registration fee and \$10 per day.
- Without two weeks' notice, you will be billed for the entire tuition.
- The **\$10** deposit may not be transferred to another day.
- Additional days may be added when space is available, upon payment in advance.
- With <u>two weeks' notice</u>, you can make <u>one change</u> in your schedule and not be charged the \$10.00 deposit (max of 5 days).
   The deadline for this change is June 16.

## Waitlist:

- You can place your child on the waiting list on full days.
- A \$10 per day deposit is required. It will be refunded in full if your child does not get in.
- Don't forget to check to see if your wait-listed child got in for the day, before sending him or her.

### Refunds:

• You can request a refund after Week 7. Your refund will be mailed or credited back on Vanco to you upon confirmation of the amount by our treasurer. There are no refunds for days missed without two weeks' notice.

## Call in absences:

- Please call as soon as you know that your child will not be attending.
- Our answering machine is always on. No refunds will be given.

# Field trips:

- ASC tee shirts must be worn on all field trips.
- Extra tee shirts are available at \$10 each.
- Water bottles are available at \$1 each.

## Bringing in personal items:

- The ASC is not responsible for **electronic items** (including, but not limited to, iPods, smart phones, hand-held video games, smart watches or other items like Pokémon, money, etc.) should these items get lost or damaged.
